### Style sheet

#### I. Text

- Articles: 20 pages (2300 signs per page), max. 46000 signs (or 50000 with spaces)
- Author: Name, affiliation, email  
(ex : Corin Braga  
Babes-Bolyai University, Cluj-Napoca, Romania  
CorinBraga@yahoo.com)
- Title: if the paper is not written in English, the author should provide its English translation
- Abstract (10 rows max.) and Keywords (5-10) in English
- Page Size: A4, portrait
- Page Setup: Margins 2,5 cm top, bottom, left, right
- Page numbers: Bottom of page, centre, continuous
- Line and page breaks: None (No Widow/Orphan Control)
- Font TimesNewRoman Size12, Line spacing 1,5, justified
- Large citations: Size 11, Indentation 0,5 cm, No quotation signs
- First line indent: 0,5 cm
- End Notes, Continuous numbering
- Words in other languages in Italics
- For highlighting, use only Italics (not Bold or Underline)
- Bibliography at the end of the text
- Avoid all complex editing

- Paper or chapter in collective volumes: Vasoli, Cesare, "Il carattere 'naturale' dello Stato e la sua patologia nella tradizione politica aristotelica", in Enzo Baldini (ed.), *Aristotelismo politico e ragion di Stato*, Firenze, Olschki editore, 1995, p. 53-65.

#### III. Special indications

- The place (city) goes before the name of the editor
- The titles of books and journals go always in Italics
- The titles of articles in a journal and of papers or chapters in a collective volume are separated by quotation signs
- Pages are indicated by p. (and not pp.)
- The quotations in other languages should be translated in the text and, if necessary, reproduced in their original language in note
- The first note reference is complete (author, title, place, editor, year, page).
- The next references use *Idem*, *Ibidem* and *Op. cit.*.
